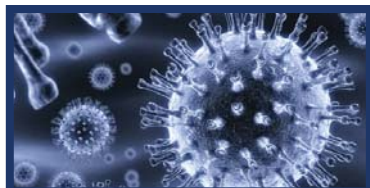




## Infectious Disease Steering Committee

CSTE's infectious disease subcommittees are among the largest and most active groups in CSTE. In alignment with their respective local, state, and territorial public health departments, CSTE members collaborate with federal public health programs (e.g., CDC, FDA, and USDA) and sister organizations (e.g., APHL, ASTHO, NACCHO, and NASTAD) to support projects related to infectious disease research, surveillance, preparedness, response, and prevention.

Members of infectious disease subcommittees collaborate with other subcommittees to facilitate the investigation, identification, diagnosis, treatment, and prevention of disease. In their efforts to prevent further spread of infectious diseases and encourage timely reporting, subcommittee members participate in the annual CSTE position statement process. This process updates case definitions for various infectious diseases and amends the list of nationally notifiable infectious diseases.
